TERMS AND CONDITIONS

These terms and conditions are for all entrants who enter the 'Win Your Way' ("Promotion").

Participation in this Promotion is deemed acceptance of these Terms and Conditions.

The "Promoter" is ISPT Pty Ltd and managed by CBRE Pty Limited (ACN 057 373 574) of Level 21, 363 George Street, Sydney NSW 2000.

- 1. Entry is only open to Australian and VIC residents aged 18 years or over
- 2. Entries into the promotion open at 9:00am AEST on Saturday 29 March 2025 and close at 5:30pm AEST on Wednesday 30 April 2025 ("Promotional Period").
- 3. A participating shopping centre is any shopping centre located in Australia that displays material relating to the promotion during the Promotional Period (each a "Participating Shopping Centre"). See Annexure A for a list of Participating Shopping Centres.
